## PLAYER DUES BASIS 2009-2010 FINANCIAL RESPONSIBILITY AGREEMENT

This agreement contains the details and family commitments outlined, in its entirety, on the **Capital City Volleyball Club / Team Complete Athlete** website ([www.myccvc.com](http://www.myccvc.com)), for the Capital City Volleyball Club / Team Complete Athlete (CCVC / TCA) members. The basis of the dues includes, but is not limited to, tournament registration costs, coaches' pay and expenses, gym costs, and CCVC / TCA equipment and operation costs. Also, this agreement relates to details pertaining to the specific costs and expenses that are IN DUES or are not IN DUES.

The purpose of this agreement is to ensure that all CCVC / TCA members and their parents have visited the website, read and understood the financial commitments and responsibilities, are familiar with the financial commitments required to participate with CCVC / TCA, and that their respective signature(s) below affirms this understanding and promise to fulfill ALL necessary financial commitments to support their respective CCVC / TCA team during the entire 2009-2010 Club season.

Dues are paid to the club as a whole and not to individual team accounts. CCVC / TCA does not give dues refunds for any reason, including a team or a family decision not to attend a budgeted tournament. CCVC / TCA assists in securing hotel accommodation for the tournament budgeted in the season programs. CCVC / TCA highly discourages swapping tournaments that are in the budgeted programs for other tournaments.

If a (-1, -2, -3, -4, -5) team that my daughter plays for, through a majority vote that fields at least 8 players, elects to participate in **any tournament that extends beyond the month of April**, it is the responsibility of the team rep and the families to secure hotel accommodation and submit the team registration on time to the registrar at CCVC / TCA.

I hereby affirm, through my signature below, that I understand the basis of the Capital City Volleyball Club / Team Complete Athlete (CCVC / TCA) dues and how the dues are estimated as outlined on the CCVC / TCA website ([www.myccvc.com](http://www.myccvc.com)).

I understand and agree, through my signature below, that the dues cover practices, tournament registration costs, coaches' pay and expenses for the months of December through April as set in the Season Dues Summary.

### IN-THEN-OUT Clause

If any (-1,-2,-3,-4,-5) team that my daughter plays for, through a majority vote that leads fielding at least 8 players, elects to participate in **any tournament that extends beyond the month of April**, or extends the season to include any tournament in addition to those identified in the Season Dues Summary, I agree to the following:

- If I voted in favor of my daughter participating in the tournament, I will physically support the team by having my daughter participate in the tournaments.
- If I voted in favor of my daughter participating in the tournament, I will financially support the team by paying the pro-rated per player amount for **coaches' pay, coaches' expenses and tournament registration**.

Payment shall be sent to the CCVC / TCA Team Rep **prior to registration for the event that causes the sum to be exceeded and immediately following a request for payment. This is regardless of whether my daughter chooses to do the "IN-THEN OUT" form of attendance to the tournament(s) or not.**

**IN-NATIONALS Clause**

If my daughter plays for a -1 CCVC / TCA competitive travel teams that play at the Platinum/Gold level, I agree to the following:

- I agree to register to qualify to attend the USAV Junior Nationals event in June/July.
- If the team that my daughter plays for wins a qualification bid to attend the USAV Junior Nationals event in June/July, I agree to the following:
  - I agree to support the team by having my daughter participate in the USAV Nationals tournament.
  - I agree to financially support the team by paying the pro-rated per player coaches' pay, for the months of May, June/July up to and including the Nationals tournament.
  - I agree to financially support the team by paying the pro-rated per player coaches' expenses and USAV Nationals Tournament registration.
  - **Practice gym expenses at 2 days per week are covered by CCVC / TCA.**

**Note:** In the past CCVC / TCA has donated club funds towards attending Nationals for these Platinum / Gold, -1 teams; However this is **NOT** guaranteed.

I agree to this provision as a commitment to accepting an invitation for my daughter's participation on a CCVC / TCA team. I also understand and agree that the CCVC / TCA Executive board will impose consequences that could adversely affect my family's participation with CCVC / TCA in the event the obligation I have agreed to herein is not fulfilled. I understand the estimated expenses for my CCVC / TCA team are available for my review if requested.

I agree to indemnify and hold harmless Capital City Volleyball Club / Team Complete Athlete, its partners, officers, employees, and any organization co-sponsoring the program, from and against any and all liability arising out of or in any way connected with the dues, additional tournament costs, coaches pay and/or coaches' expenses and travel.
